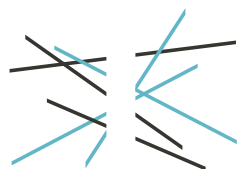

About the Traffic Penalty Tribunal

The Adjudicators of the Traffic Penalty Tribunal (TPT) decide appeals against penalties issued for traffic contraventions by enforcement authorities in England (outside London) and Wales.

This includes appeals against civil enforcement penalties issued by local authorities for parking, bus lane and (in Wales only) moving traffic contraventions, as well as appeals arising from road user charging enforcement.

The road user charging schemes that the TPT decides appeals for include the:

- Dartford-Thurrock River Crossing ('Dart Charge'), where the charging authority is the Secretary of State for Transport.
- Mersey Gateway Crossing ('Merseyflow'), where the charging authority is Halton Borough Council.
- Durham Road User Charge Zone, where the charging authority is Durham County Council.

The TPT comprises part-time Adjudicators (wholly independent lawyers whose appointments are subject to the consent of the Lord Chancellor)

with the support of administrative staff, who provide customer support and process appeals.

The TPT is funded by a Joint Committee of over 300 local authorities: Parking and Traffic Regulations outside London (PATROL). PATROL fulfils a statutory duty to make provision for the independent adjudication.

In England, the process for appealing parking penalties is underpinned by the Traffic Management Act 2004 and the Civil Enforcement of Parking Contraventions (England) Representations and Appeals Regulations 2007.

Bus lane penalty appeals are underpinned by the Transport Act 2000 and the Bus Lane Contraventions (Penalty Charges, Adjudication and Enforcement) (England) Regulations 2005.

Road user charging appeals are underpinned by the Transport Act 2000 and the Road User Charging Schemes (Penalty Charges, Adjudication and Enforcement) (England) Regulations 2013.

In Wales, the appeals process for parking, bus lane and moving traffic penalties is underpinned by the Traffic Management Act 2004 and the Civil Enforcement of Road Traffic Contraventions (Representations and Appeals) (Wales) Regulations 2013.

Introduction and Executive Summary

This report presents statistical information on Penalty Charge Notices (PCNs) appealed through the Traffic Penalty Tribunal during the period 1 April 2017 to 31 March 2018.

The statistics encompass information on PCNs issued and appeals made in local authority areas for parking and bus lane contraventions in England (outside London), and parking, bus lane and moving traffic contraventions in Wales.

The statistics also cover PCNs issued and appeals made in respect of the following road user charging schemes:

- **Dartford-Thurrock River Crossing ('Dart Charge').**
- **Mersey Gateway Bridge Crossings ('Merseyflow')**

Year-on-year comparisons are also included for each set of statistics (where applicable).

10,460 appeals, down from 21,017 in 2016/17
- **Merseyflow:**
3,472 appeals (enforcement commenced in 2017/18)

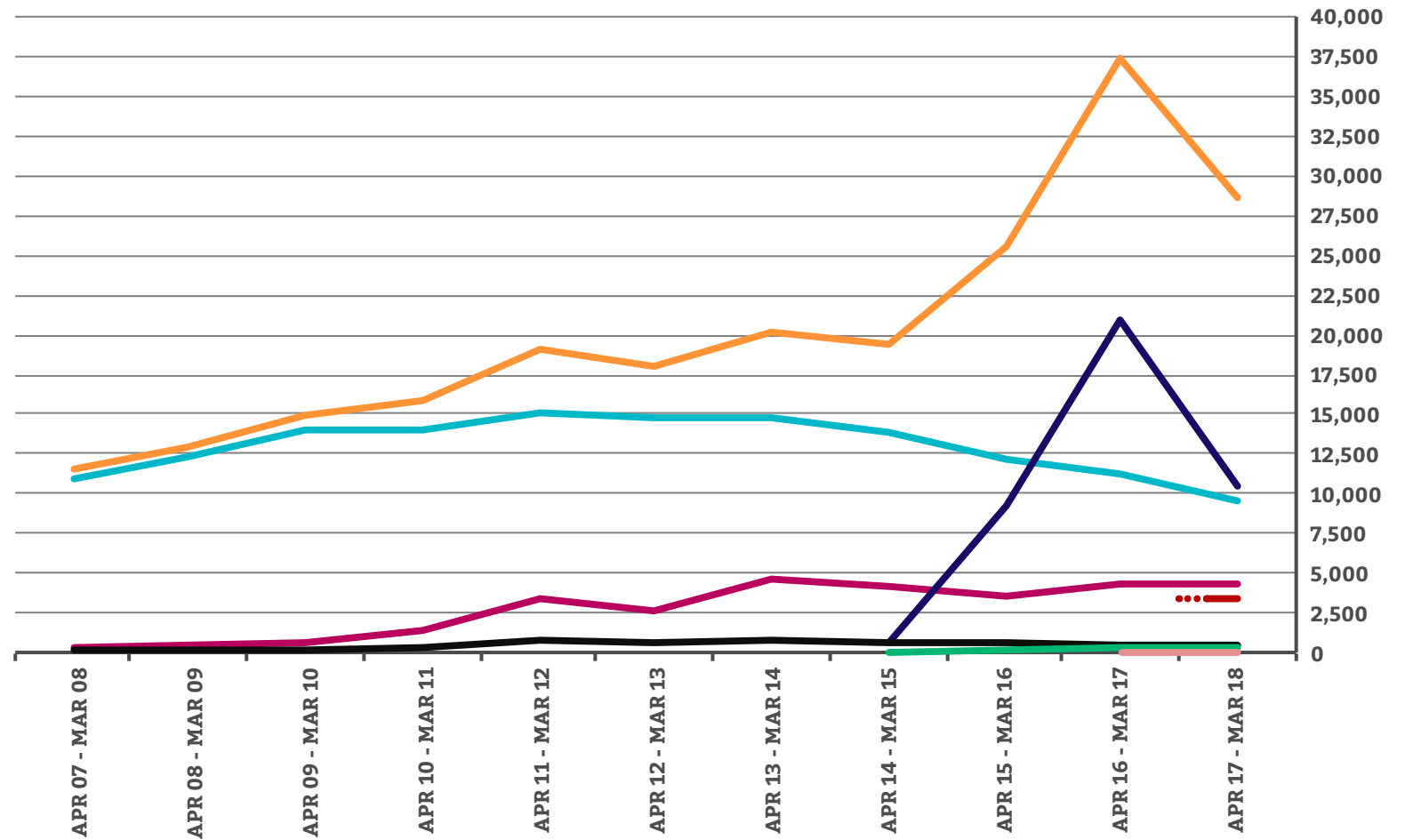

- The number of Parking PCNs issued by English authorities that were appealed to the Tribunal was 9,566, a decrease of 15.0% from 2016/17. The rate of appeal was 0.21%.
- The number of Parking PCNs issued by Welsh authorities that were appealed was 489, a decrease of 2.4% from 2016/17. The rate of appeal was 0.23%.
- Authorities introducing civil parking enforcement during 2017/18 included: Buckinghamshire District Council, North Somerset Council and South Wokingham Borough Council
